Clerk gave an update on the past due utilities report.

Water Tower: Hansen reported that he has been in contact with Maguire Iron because the water tower has a small leak. They will be coming to fix it.

Community Center – Clerk reported that the new south door will be installed this week.

First Reading of Ordinance 01-2017 AN ORDINANCE RAISING WATER RATES to amend water rates in Appendix A, Section 3.3 of City Code of Ordinances due to increase from Iowa Lakes Regional Water. Appendix A, Section 3.3 shall read as follows: For the first 1,000 gallons of water utilized by a customer per month and lesser gallonage, the monthly water rate shall be \$28.00; and for any amounts over 1,000 gallons of water utilized, the monthly rate for each additional 500 gallons or portion thereof shall be an additional \$3.00 per month.

Said rates may be collected either on a quarterly basis or on a monthly basis, or on any other schedule as deemed advisable by the Webb city council. Motion was made by Meyer to approve the first reading of Ordinance 01-2017. Hansen seconded the motion. Roll Call vote: Meyer-Aye, Greene-Aye, Fritz-Aye, Hansen-Aye. Motion carried.

Fritz motioned, seconded by Greene to approve the building permit for Lynn Meyer. All present voted aye, with Meyer abstaining. Motion carried.

City Elections: The position of mayor and 3 council positions will be up for election this fall. Clerk has papers ready at city hall for all interested in running for council or mayor positions. Completed papers must be filed with the city clerk between August 28 and by 5:00 pm on September 28.

Motion to adjourn was made by Meyer and seconded by Greene.
